# Compliance and Regulatory Affairs (CRA)

AMTA Full Carrier Members provide financial support to AMTA through annual membership fees, ensuring we keep road transportation issues and needs at the forefront of provincial, federal and international agendas. AMTA works with senior leaders of truck and bus fleets to develop and advocate for solutions to road transportation issues and opportunities. Compliance and Regulatory Affairs (CRA) responds to the problems, challenges and opportunities that are impacting our member companies.

To be effective advocates for the issues that matter most to fleets that operate in Alberta, our programs and initiatives

also aim to educate and inform our stakeholders and the general public about why those issues should matter to them, too. Advocacy issues include permitting, driver training, fatigue management, Hours of Service, on-road safety performance and transportation career pathways.

On trucking issues of a national scope, we work in tandem with the Canadian Trucking Alliance, the federation of provincial trucking associations. Similarly, we work with the Canadian Motor Coach Association to advocate for the motor coach industry. AMTA also participates in the Canadian Council of Motor Transport Administrators, Commercial Vehicle Safety Alliance (Western Hemisphere), and the Task Force on Weight and Dimensions.
